OVERVIEW

Pennsylvania enjoys a diverse and dynamic creative sector that is propelled by a diverse and skilled creative workforce. According to the Bureau of Economic Analysis, in 2021, there were over 165,000 Pennsylvanian's employed in arts and cultural production. The Pennsylvania Council on the Arts (PCA) recognizes the important role that the creative sector plays in PA's economy and the opportunity to develop support systems and policies that ensure that PA is a leader in developing and retaining a creative workforce.

As a step in advancing our understanding of PA's creative workforce, the PCA is issuing this Request for Proposals (RFP) to support a research project that takes a quantitative and qualitative approach to describing key attributes of PA's creative workforce, including but not limited to, its size, composition, geography, challenges, and opportunities. The PCA anticipates using the results of this research project to inform our planning processes and investments, as well as sharing with stakeholders across Pennsylvania.

AWARD

PCA anticipates approving one applicant with a non-matching award of up to \$125,000.

PROJECT LENGTH

Applicants may propose a research project with a scope lasting up to 24 months.

FLIGIBILITY

Applicants must be a nonprofit, tax-exempt corporation, a unit of government, or a non-profit college or university.

REVIEW CRITERIA

Responsiveness of Proposed Approach and Implementation Plan - Applicant demonstrates a responsiveness to this RFP in the proposed approach, implementation plan and proposed project budget.

Experience with Comparable Projects - Applicant demonstrates a successful history of conducting comparable research projects.

Capacity - Applicant demonstrates organizational and key project staff capacity to carry out the research project as proposed.
